REPORT TO AREA D SOUTHERN REGION LISA ROWE | DELEGATE

INTRODUCTION

This is my final report as Delegate for Area D.

On page 89 of our Big Book, the phrase 'this is an experience you must not miss' appears. It is in the chapter about working with others, however, having just attended my first and only face to face General Service Conference as a Conference Delegate, I can emphatically say that this is the first phrase that came to mind when I sat down to write this report and reflect on that experience.

I have been very fortunate to be a 3rd year Delegate in the year the decision was made to change the committee structure of Conference. This shift from 12 service-area specific conference committees to 3 generic committees also included significant changes to the previous Conference agenda committee (now the steering committee) which as a 3rd year delegate I served on, and I also chaired one of the 3 new Conference committees. The inaugural 2023 CSC was tasked with implementing the structural changes to the planning and execution of Conference this year. We knew this was a large undertaking, made more complex with the departure of our long-standing GSO Manager mid-year. So, it has been all hands on deck, with the steering committee meeting largely weekly since June, to implement the changes as well as supporting the 2 remaining GSO staff members in the organizing of Conference. I feel confident that the work of this steering committee will have a lasting legacy. I am especially proud of changes that enhance the spiritual decision-making process, such as the Day 2 "What's on Your Mind" session and the appointment of a Delegate as Conference Chair.

It was all worthwhile once 30 Conference Members were finally sitting in a room together on the first weekend of November in 2023 to carry out the business of the 65th Australian General Service Conference. It was a vastly different experience to the last 2 years of Conferences held online. I was solidly reminded throughout the weekend that AA is in very good hands. While several Areas are currently not active or do not have an elected Delegate, those present demonstrated a passionate commitment to the surviving and thriving of AA in Australia. Being part of our decision-making process where differing opinions were expressed and harmoniously accepted, and where a single minority voice opinion can completely reverse a decision, was something I am very grateful I did not miss.

It has been my busiest year general service wise — and also the most rewarding. I have spent the last few years living in regional areas where a connection to AA as a whole is currently not present. I have not had a home group that is attached to the General Service Structure during that time. This service position has kept me sane, grounded and connected to a primary purpose throughout.

The steering committee is currently finalising our work, taking into consideration post-conference learnings, and preparing to hand over to the 2024 committee. It has been a real pleasure to hang out with a group of people every week focused on a shared purpose of delivering the best outcomes for AA as a whole and I will genuinely miss this connection when we disband. However, as a result of the significant changes this year, the Australian AA Service Manual is going to need a major revamp and rewrite – I have put my name down to serve on that working group. Glutton for punishment some would say – I prefer to think of it as staying sober in the nicest possible way.

I encourage all members to keep their eye on the national member website (members.aa.org.au) for expressions of interest in joining the various working groups being formed to execute this year's Conference advisory actions.

Thank you to Area D for allowing me to serve AA in this way for the last six years.

TOPIC #017/2023: (Gold Coast Bid to Host NatCon 2026)

Gold Coast, Area C, North-Eastern Region host the 2026 National Convention of Alcoholics Anonymous, Australia.

TOPIC #019/2023: (Shorten Class A Trustee Terms)

The General Service Board consider changing the current Class A Trustee term from 5 years to 3 years plus an optional 4th year plus an optional 5th year should the Class A trustee and the board wish to exercise one or both of those 1-year options.

The Conference Committee #1 recommends to Conference that TOPIC #019/2023 be accepted as it may attract more people to apply for Class A Trustees.

I originally voted against the recommendation after this discussion.

A previous advisory action also allows a Class A Trustee who rotated off early to complete their term later. It was also noted that the literature re: Class A Trustee terms states may serve up to 5 years.

TOPIC #022/2023: (Electronic 7th Tradition)

Our home group would like guidance from the GSO regarding electronic transfer of payments for 7th tradition, and suggested methods for home groups to facilitate this. We seek guidance on anonymity and legal/administrative issues with bank transfers, and prioritising allocation of funds to home group running costs before splitting the remainder to 60-30-10 (or 50-30-10-10).

The Conference Committee #1 recommends to Conference that TOPIC #022/2023 be accepted. A report from the Finance Working Group will be presented at Conference 2023. This report is based on Advisory Action 2017/023 which resolved that the GSB be requested to research cashless options available and produce an information sheet for groups that wish to become cashless for Conference 2018.

There are only two situations in which the Alternate Delegate can be seated at Conference: -

if there is an elected Delegate who, for some reason, is unable to attend Conference; and

when the Delegate position is vacant. The Alt Delegate will be considered as having served one year as a Conference member and will only be permitted to attend two more Conferences in the Delegate position. (i.e., 3yrs)

be replaced by:

*A Delegate serves one term of three consecutive years. It is strongly recommended that a delegate serve a single term. An Alternate Delegate may, after attending one Conference in place of the Delegate, be elected to serve a full three-year term. (*please note, this is the wording used in the US/Canada Service Manual).

The Conference Committee #1recommends to Conference that TOPIC #030/2023 be accepted with the following changes.

There are only two situations in which the Alternate Delegate can be seated at Conference.

1.If there is an elected Delegate who, for some reason, is unable to attend Conference and,

The Committee recommends to Conference that the topic be accepted, and that the GSB present a simple, standardized overview/snapshot of the financial position of the GSB at each Board meeting that can be shared with Area Delegates and GSR's. This provides transparency and gives groups an opportunity to adjust their contributions throughout the year to assist in AA Australia remaining solvent.

TOPIC #014/2023: (Acknowledgement of Country Statement at AA Meetings)

..... The General Service Conference needs to address use of an AoC statement by AA Groups and Service entities. We recommend soliciting input from AA Groups around the country, with particular reference to how use of an AoC relates to our Primary Purpose, and the experience and wisdom contained in the Twelve Traditions and AA Preamble.

The Committee recommends to Conference that TOPIC #014/2023 be rejected. While further action is required to explore ways in which AA can more effectively carry the message to First Nations people, this is unrelated to use of an Acknowledgment of Country statement at groups, conventions, committees, or sub committees, where group autonomy applies.

Topic #016/2023: ('Welcome to Country' at National Conventions)

The Board and Conference direct the host planning committee of the National Convention to not include a 'welcome to country' or 'acknowledgements of traditional owners' announcements or any other political activism during the convention.

The Committee recommends to Conference that TOPIC #016/2023 be rejected. Inclusion of a Welcome to Country or use of acknowledgement of country at conventions is up to each Host Planning Committee. Noting that the Host Planning Committee is accountable to but not directed by the General Service Board. The committee would also like Conference to consider that Advisory Action 46/2014 recommended that the GSB Chair include an Acknowledgement of Country in their welcoming address.

The Committee recommends to Conference that TOPIC #021/2023 be rejected. Consensus of current and previous delegates seems to be that 3 years is the appropriate term of service taking into consideration the learning curve of the role. Furthermore, under the new committee structure 3rd year delegates sit on the Conference Steering Committee, are eligible to chair a conference committee and even eligible to be chair of conference itself.

Minority voice – that 2 years might be good for some, while others feel able to continue. What about multiple terms, e.g. 2 years with an option for another 2 years? No-one wanted to change their vote. Might see a topic about this next year.

TOPIC #023/2023: (Volunteers for Phone Line)

Conference to consider asking for volunteers from any location around Australia to assist in answering the 24-hour phone help line.

The Committee recommends to Conference that TOPIC #023/2023 be accepted noting that the Sydney City CSO is currently the default answer line (for unanswered calls). The committee recommends options be explored for an expanded model to ensure all calls made to the National AA helpline get answered. They could be added to Area E Eastern Region roster (as suggested in the topic) or coordinated some other way, such as a CSO or an AA phone service in each state or region be the default answer line for unanswered calls.

A printed loose-leaf version of the manual or guidelines can already be ordered from the GSO for approx. \$17 plus postage. The committee recommends that going forward these custom ordered printed versions be sent in a binder with instructions to add or replace new pages when updates are released/advised.

The reason for this recommended change is to clarify the guideline's intention that group GSRs reside in Australia. A group's GSR should be able to become a member of the Area Committee, which requires them to be a legal resident, and/or become the elected Area Delegate or Alternate Delegate, which requires them to attend the general service conference in Australia.

The Committee recommends to Conference that TOPIC #031/2023 be accepted and that the virtual area guideline be updated as written in the topic.

In comparison, secular AA meetings in Australia are relatively new with a steady increase in the number of meetings and attendees in recent years, both face to face and on-line. All are listed on the Australian AA website, where many discovered secular AA meetings by chance. The awareness and visibility of secular AA groups in Australia requires enhancing. This leaflet is a succinct trifold, double-sided leaflet which has been designed for this purpose.

While the committee broadly supports the efforts that have gone into producing the attached pamphlet, the committee rejects this topic and refers conference to topic 015.2023. However, during the board's deliberations on topic 015.2023, the committee recommends the board take this pamphlet into consideration

Q & A ON REPORTS

General Service Office Report

Q: Re: *all insurance policies for the office and the groups are up to date.* What sort of things are registered online groups covered for under AA's national insurance policy?

A: All liability related to personal injury, etc. e.g., if someone did sue an AA group for trauma as a result of Zoom bombing or trolling, the group would be covered.

Q: Concern by not employing a GSO Manager or appointing a proxy, the Board has denied the GSO a vote at this year's conference. This is in direct conflict with Concept IV. This is not just about numbers. It is a recognition of the value of our office staff. At the US/Canada Conference, around 15 of the 100 odd office staff have a vote.

The GSO Manager role is embedded in our general service structure, our conference structure, our service manual and our conference charter.

A: The Board is really trying to balance the Board's roles and responsibilities for managing funds, etc with AAs Concepts and principles.

- The Board / Management group doesn't intend or want to manage the office, they are in a process and need some time.
- Not just about the right person, need to understand exactly what the role is.
- They are consulting closely with the current staff re: what they do and what's needed.
- The outgoing Board chair did draft a PD for the office roles when she started but it wasn't developed or finalised.
- There has historically been a lack of processes and procedures and knowing what the role would actually be managing. Cannot recruit until they are clear on this.
- Working out what can best be outsourced and what needs to stay in house.
- 13-15 cents in the dollar was allocated in the budget to the GSO Manager role. It's significant and must be taken very seriously and not rushed.
- The General Service Trustees are excavating many years of business as usual with no rotation
- Need some time to finalise.

Technology and Social Media WG Report and Websites Reports

Q: Analytics reports provided and no mention of the member website in the tech WG report. What kind of development work is taking place with regards to the member website - what are the plans, is a website editor going to be recruited, are their plans for members to be able to join a committee and assist with content management, etc.

A: Lots happening and being refined. Any website guidelines developed would be put to Conference for approval. Content management expansion in scope but further down the track.

Members can contact Grant if interested in being part of the tech and social media committee.

The Conference Steering Committee recommends that the CSC investigate the most cost-effective way for key audio recordings of the 2023 conference be transcribed to text and edited, for archive and easy reference as well as to form the basis of the Conference Report. *Carried by show of hands*.

WHAT'S ON YOUR MIND

New session for Conference, held first up on the morning of Day 2. The intention of this session was for Conference members to share any *new* information, thoughts, questions or insights on the decisions made the day before.

What was on Conference Members' minds:

- There was a finance working group report to Conference included in a recommendation but the report had not been heard. This was raised and rectified.
- In the suite of Bridging the Gap Correctional Facilities materials that were approved there were business cards with a QR code linked to meetings list. Class A Trustee advised no phones in facilities. It was confirmed that the cards are intended for when someone is leaving the facility.
- Message Stick cost to print. Could we engage with the international sponsorship fund, for example, to assist with being able to provide copies to indigenous members? Will be explored by the GSB. It is also an opportunity for local PI committees to raise funds to get copies for local regions, etc.

BIDS

- The 2026 National Convention will be held on the Gold Coast.
- Areas A and B CR submitted a combined bid to host a regional 2025 Regional Forum. Bid accepted
- Area H ER bid to host a regional forum in 2024. Bid accepted.
- It was noted as a point of order that bids should be submitted 2 years in advance with evidence of full support of the Area, but that this process was not reinforced last year so a bid was accepted for next year.

ELECTIONS

- World Service Delegate 3 applications. 4 rounds of voting went to the hat.
 Elected: Andrew Poad.
- RATIFICATION OF CLASS A TRUSTEE APPOINTMENT: Matthew Church. Passed.
- RATIFICATION OF GENERAL SERVICE TRUSTEE APPOINTMENT: Gabrielle Nicholson. Passed.

FLOOR ACTIONS

- 1. That a QR code for the Chat Now function be added to all reprints of PI Posters. It was agreed to add stickers with the QR code linking directly to the national website to existing posters. To be delegated to the tech team for action.
- 2. **In the topic background for Proposal for a Secular Leaflet TOPIC #025/2023: it reads** re the proposed flyer that *it was accepted and displayed on the literature table at the Perth convention.*

Floor Action: That it be added to the National Convention Guideline (GL-15) that only conference approved literature be displayed on tables at National Conventions. Not to include event flyers or similar. The discussion raised also that the non-conference approved flyer in question had a conference approved logo on it. A small working group will be formed to revise the Nat Con guidelines.



GSO staff member advised that a more cost effective way to pack and ship the banners has been identified and it was agreed earlier this year to go ahead with these banners. In progress.





Observations / comments -

- Travel expenditure \$11k (2022) \$97k (2023). Perth travel costs \$30k. Hobart \$15k. GSO staff went to events in Cairns \$5k. Balance mostly board meetings and incidental travel.
- Audit provision \$14k. This seems very high based on my own personal, professional experience
 of audit costs.

Questions asked -

• 22/23 Conference Levies \$34,500. Conference and convention costs combined shown as \$27,326. \$6k of that was deposit for the 2023 Conference venue. I asked what the projected cost is for this year's Conference. Answer from GSB is unknown at this stage as historically there

has not been a clear process for determining this. Finance committee is working on one so that Conference levies can be more accurately calculated going forward.

• Donations for year \$478,446. Operating costs after one off expenses are taken out are \$551,634. Bottom line - operating costs still being subsidised by literature sales.

The General Service Board have identified savings of approx. \$85,000 in the areas of travel, Conference and relocation expenses.

Adjusted expense figure is \$551,634 per annum, \$45,969 per month and \$10,608 per week

Contributions

Contribution goal per week \$10,608.34

Average contributions from July to present per week \$7269.24

Leaving a shortfall of \$3,339.10 per week and \$56,764.7 year to date

Observations / comments -

- Taking steps to reduce board member travel and travel expenses overall
- Current prudent reserve status \$724,540 (11.9 months).
- Project fund current balance \$136,467. Noting Message Stick printing (approx. \$30k), Auslan project costs and other projects nearing completion will come out of this
- Average contributions since July 2023 have dropped from \$10,608 \$7269. YTD shortfall (against operating expenses) already \$56,764.

Increasing contributions from members and groups remains a high priority.

Groups hold the power of the purse.

ASK IT BASKET

1. How can we help ensure conference topics are coherent and not repetitious?

The CSC is currently working on an amended topics form as well as broader criteria for where submitted topics are sent and what topics go to Conference, and better guidance for the Conference committees. We are working towards a long-term goal of topic submissions being open most of the year, with a reasonable cutoff date.

2. How will members be able to apply to join working groups that need to be formed to carry out Conference advisory actions?

Once the materials are ready, the details of working groups as well as the 2024 topics form will be published on the members website.
